This is an exciting time to join Magic Me. In 2019 we plan to grow our activities, within our home borough of Tower Hamlets across London, and into the east of England, trialling new approaches to intergenerational community building, and delivering an organisational wide strategy.

Our Board of Trustees will be a key part of this growth. We are looking for three new trustees who each bring their own set of skills in one of the following areas:

- A member our local community keen to use their voice and passion for the arts to engage with big ideas. You may have previously taken part in a Magic Me project or have clear ideas on how the arts can support communities. No prior experience is necessary for this role, we welcome applications from anyone aged 16+
- Treasurer you will have extensive experience in charity finance and maintain an overview of Magic Me's financial position to ensure its financial viability and that correct records and procedures are maintained. The Treasurer chairs the finance, audit and risk sub-committee.

- 3. Fundraising you will be experienced in fundraising across the arts sector and support the ongoing development of Magic Me's fundraising strategy. Our lead trustee on fundraising will chair the fundraising sub-committee.

A: ABOUT MAGIC ME

Magic Me arts projects challenge people to stretch themselves and what they think they can do and be. Working with highly skilled and experienced artists, they learn new skills, share their ideas and feelings, and become comfortable collaborating with people who are different in age, ethnicity or life experience.

All our activities are run in partnership with other organisations, large and small. We have delivered hundreds of projects with thousands of people in schools, care homes, galleries, museums, open spaces and community centres. We are a learning organisation - time for participants, artists and staff to reflect on their progress is integral to our approach.

This year Magic Me celebrates its 30th birthday, since its founding in 1989, Magic Me has pioneered intergenerational arts practice. Our story for the past 30 years has been one of innovation and constant evolution in the field of intergenerational practice. Based in Tower Hamlets, east London, Magic Me is growing to serve other communities in outer east London and the east of England.

Magic Me Charitable Objects:

To promote, maintain, improve and advance the education of children and adults towards a better understanding of ageing and the needs of elderly people, and methods by which those needs may best be met.

Mission and Values

Magic Me's mission is to bring the generations together to build a stronger, friendlier community.

We do this by bringing together people of different ages as equals, with a shared creative purpose. For many, this is a new experience. Our activities provide a secure place in which to explore similarities and differences, and young and older people often find they have much in common. Creative activity is the focus for meeting and the process through which participants explore and share their ideas and feelings.

Finances

Magic Me is a registered charity with a broad funding base that punches well above its weight. Magic Me receives no core finding from public sources and relies on the generous support of a wide range of grant-making trusts, local authority grants, corporate supporters and individual donors. Our annual budget for 2019/20 is £519,667.



B: BECOMING A TRUSTEE

Who are we looking for?

Magic Me Trustees have a wide range of backgrounds, interests and experiences. Magic Me operates within many sectors and is keen to have a wide range of professional and community expertise from its Board, alongside excellent governance to support the charity to deliver on its mission and to safeguard its values.

The aim of our board of trustees is to govern Magic Me and enable the charity to be the best that it can be, steadfastly focused on achieving its vision, mission and purpose, so as to transform the lives of the beneficiaries we serve.

We are looking for trustees who can support the chair and director with the leadership of Magic Me.

You will act as an ambassador for Magic Me and promote our work at public event s and more widely within the sector. You will be happy to make and use connections to advance Magic Me.

Our board is currently made up of nine trustees and we are looking to increase this to ten. We are keen to create more diversity on our board and ensure we continue to represent the people we work with.

We are looking for new Trustees to participate in the governance work of the board, who have a range of skills and a commitment to supporting Magic Me in a very practical way.

To complement current trustees we are particularly looking for people with experience in one or more of the following:

- Participating in community arts
- Charity finance
- Charity governance
- Fundraising

Our aim is also to have a balanced board, which includes people from the different communities, generations and cultures within which we work.

Legal position

Magic Me is a registered charity and trustees are legally responsible for its operations. Their role is to oversee the organisation, its staff and long-term strategic planning. Technically trustees employ the staff of Magic Me, who are responsible for most of the day to day running of the organisation. Trustees are also Directors of Magic Me Ltd, a company limited by guarantee. This is a way of ensuring that no trustee who has fulfilled the duties of their role is personally liable should the organisation become insolvent or have to close.



Magic Me's public liability insurance covers everyone who works for Magic Me, whether paid or unpaid, and this includes Trustees while working on Magic Me's behalf, as well as staff, freelancers and volunteers.

Trustees are elected at the AGM, usually held in October, by the members of Magic Me. Current Trustees may also co-opt new Trustees during the year between AGMs.

Practicalities

By law, charity trustees cannot be paid for their time and work. Trustees can claim reasonable travel, childcare or other expenses as necessary.

Time Commitment

Realistically to fulfil your role effectively, being a Trustee is likely to involve around half a day a month of your time.

- Trustees meet formally four times a year, usually from 6 to 8pm on a weekday evening at Magic Me's office in Bethnal Green. These meetings are held on different days of the week to accommodate people's other regular commitments.
- Magic Me has three sub-committees on which trustees can serve they are: Finance and Risk Committee, Fundraising Committee and HR Committee.
- Papers for meetings are circulated by email at least seven days before the meeting. Trustees are
 expected to prepare for meetings, having read and digested the papers in advance and be ready
 to contribute to discussions and decision making.
- We also aim to hold an off-site away day each year to reflect on how we are working as a team, and to focus on big picture matters for the charity.
- The AGM is held as part of Magic Me's Annual Celebration, usually in October.

APPENDIX 1 - SPECIFIC RESPONSIBILITIES FOR TREASURER

In addition to the role outlined above for all trustees the treasurer chairs the finance audit and risk committee and has the following specific duties.

- Overseeing, approving and presenting budgets, accounts and financial statements and presentation to the board. Highlighting any concerns/issues.
- o Being assured that the financial resources of the organisation meet its present and future needs
- Ensuring that appropriate accounting procedures and controls are in place and advising on improvements to the existing process
- Ensuring that the charity has an appropriate reserves policy
- Acts as the second signatory on payments and application to funders where required
- Liaising with any paid staff and volunteers about financial matters
- Advising on the financial implications of the organisation's strategic plans
- Ensuring the organisation's compliance with legislation
- Ensuring equipment and assets are adequately maintained and insured
- Ensuring that the accounts are prepared and disclosed in the form required by funders and the relevant statutory bodies, e.g. The charity commission and/or the registrar of companies (note these are prepared by the external auditor)
- o Liaison if required with the external auditor on any year end adjustments
- Keeping the board informed about its financial duties and responsibilities
- Contributing to the fundraising strategy of the organisation
- Making a formal presentation of the accounts at the annual general meeting and drawing attention to important points in a coherent and easily understandable way
